

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.creativecarpetsllc.com and Creative Carpets LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Creative Carpets LLC include www.creativecarpetsllc.com, Creative Carpets LLC and www.creativecarpetsllc.com. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Creative Carpets LLC may collect personally identifiable information, such as your:
